In the matter of a Hearing between:

Rick Chaba - Salesperson; and Leslie Cisakowski D.R. and Irving Switzer

Upon hearing the evidence presented at the Hearing, the Hearing Panel renders the following decision:

- 1. As the Hearing relates to Mr. Rick Chaba; the Hearing Panel, under Section 45 (i) discontinues proceedings against Mr. Chaba.
- 2. In the matter of Leslie Cisakowski; the Hearing Panel finds that Mr. Cisakowski's conduct is deserving of sanction in that he failed to properly supervise the conduct of an unlicensed assistant in his office.
- 3. In the matter of Irving Switzer; the Hearing Panel finds that his conduct is deserving of sanction in that:
  - a) he held himself out as an Industry Member while under suspension by the Executive Director;
  - b) that he counselled buyers to secure a "Gift Letter" for funds for a downpayment on a house that he knew (or should have known) were not true "Gifts";
  - c) that Mr. Switzer, in September of 1997, swore a false affidavit to renew his "Authorization to Trade in Real Estate".

As to sanctions, the Hearing Panel assesses the following:

- 1. Against Leslie Cisakowski; Mr. Cisakowski is to receive a "Letter of Reprimand" and is assessed costs in the amount of \$2,959.02.
- 2. Against Irving Switzer; Mr. Switzer is to receive a six (6) month suspension of his "Authorization to Trade in Real Estate" effective from January 28, 1998, to July 28, 1998, and pay costs in the amount of \$5,918.03. It is recommended to the Executive Director that, should Mr. Switzer be granted an "Authorization to Trade in Real Estate" at the end of the suspension period that, as a condition of the Authorization, his Agent be required to meet with him weekly and report monthly as to his conduct in Real Estate Trades and/or any complaints (by members of the public or Industry Members) to the Real Estate Council of Alberta for a period of two (2) years.
